VOLUNTEERS DEDICATED OVER 7,700 SERVICE HOURS TO THE COMMUNITY AND THE CREEK, PROPAGATING AND PLANTING 3,625 NATIVE PLANTS IN THE WATERSHED. ADDITIONAL RESTORATION EFFORTS INCLUDED THE REMOVAL OF INVASIVE, NONNATIVE PLANTS; TRASH AND GRAFFITI REMOVAL; AND TRAIL MAINTENANCE.
